4. The sum of \$15.00 is hereby fixed as the fee to be paid by any person requesting that notices of meetings of the BOARD OF TRUSTEES OF THE JOINT FREE PUBLIC LIBRARY OF MORRISTOWN AND MORRIS TOWNSHIP

during the calendar year 2024 be mailed to such person as specified in R.S. 10:4-19, provided however, that no charge shall be made to any newspaper requesting the mailing of notices to its business office.
